#### Narrative

#### Carbon County Sheriff's Office Investigation Narrative

On 02/05/18 I (Deputy JW Moore) had a meeting with Deputy Carbon County Attorney Ashley Mayfield-Davis in reference to some information and photographs that she had received and wanted investigated.

Mrs. Mayfield-Davis stated that she had been notified by a subject who wished to remain anonymous that former Carbon County Library Rawlins branch manager Joshua Wood had taken photos of himself with his penis exposed within the Rawlins branch of the Carbon County Library and then posted them on the internet.

Mrs. Mayfield-Davis presented me with an envelope of photos that Carbon County Library Director Jacob Mickelson had taken screen shots and printed from a website called Fetlife.com on 12/8/17.

Mrs. Mayfield-Davis and I discused the situation and agreed I would investigate into possible violations of Wyoming State Statute 6-4-201 Public Indecency and 6-4-302 Promoting Obscenity.

I then went to the Carbon County Library Rawlins branch to meet with Jacob Mickelson.

Mr. Mickelson stated that he had also heard that about the photos so he went to the website and found Mr. Woods page. Mr. Wood was using the name writingwood.

Mr. Mickelson then took screen shots the photos that he could as identify as being taken with the library.

Mr. Mickelson stated that Mr. Wood had been hired as the Rawlins branch information specialist in July of 2016 then became the branch manager in late 2016 or early 2017.

Mr. Wood had been placed on administrative leave prior to his resignation.

Mr. Wood was under investigation for sexual harassment and the photos on the website were not discovered until after he was terminated.

Mr. Mickelson stated that he was unable to tell if the library was open or closed when Mr. Wood took the photos.

There is one photo where Mr. Wood is wearing a gas mask and goggles on his forehead. I asked Mr. Mickelson about the photo and he stated that Mr. Wood had worn those all day as his halloween costume but that they had stayed in his office after that.

Mr. Mickelson showed me where he believed the photos to have been taken.

There were several photos that appeared to have been taken in the employee restroom, several in what was Mr. Wood's office at the time and three that were taken within the public areas of the library where Mr. Woods penis is exposed.

On 02/08/18 at approximately 1240 Mr. Wood came in to the Saratoga

Police Department and met with me.

Mr. Wood stated that he had come in of his own free will and I advised him that he was free to leave at any time.

I asked Mr. Wood about the photos that appeared to be taken within the Rawlins branch of the Carbon County Library.

Mr. Wood stated that the photos were not taken while the library was open and were taken before opening and after closing.

Mr. Wood took the photos with the intention of disseminating them to other adults which he had previously spoke with. He had no intent of sharing the

pictures with minors. When the pictures were taken he did not intend to post them to his Fetlife.com page but at some point he did.

He stated that it was stupid of him to post them and that he would remove the photos that were taken within the library.

A few hours later Mr. Wood called and stated that the photos were removed from the website.

I went online and found that Mr. Wood had completely removed his profile from the site.

This report is being forwarded to the Carbon County Attorneys Office for prosecution decision.

On April 12th, 2018 I recived a letter from Carbon County Deputy Attorney Ashley Mayfeild Davis requesting Mr. Wood be issued a citation for Promoting Obscenity in violation of W.S. 6-4-302.

On April 20th, 2018 at approximately 1300 Mr. Wood arrived at the Saratoga Police Department to meet with me. I issued Mr. Wood citation 95717M for Promoting Obscenity with a court date of May 21st, 2018 at 1330 hours in Circuit Court.
